## Genre Contrast Writing Assignment

<u>Prompt</u>: Name two important differences between the two genres of "The Monkey's Paw" and explain how those differences shape the story in an important way. You will write two paragraphs, one for each difference, and each paragraph will begin *and* end with an effective topic sentence. Each paragraph will also contain quotes and correct citations from *both* the prose and drama versions of "The Monkey's Paw" in order to prove that the difference actually exists. The bulk of each paragraph will be comprised of your explanation of why/how that difference is *important* in shaping the story.

## How to Shape Your Paragraph for "The Monkey's Paw" Genre Contrast

Begin your paragraph with a topic sentence that briefly explains what the difference is between the two genres. Be sure to include key words from the prompt ("difference," "genres," and the title).

One difference between the two genres of "The Monkey's Paw" is Mr. White's rant after he loses to Herbert in chess.

Then add your first quote with the citation. The citation must immediately follow your quote.

o In the play version, Mr. White says, "That's what I can't stand about living out in the middle of nowhere like this! Every time it rains, the road gets flooded and no one can get out here. And what do those politicians in town do about it? Nothing! I suppose our three votes just don't count" (Rockliff 187).

Transition into your second quote with the citation.

In the short story version, Mr. White is still rants, but it is slightly different. He says, "That's the worst of living so far out,' bawled Mr. White, with sudden and unlooked-for violence; 'of all the beastly, slushy, out-of-the-way places to live, this is the worst.
